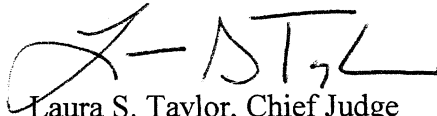
Dear Bar Leaders:

I am pleased to announce that the Court's form Individual Chapter 11 Combined Plan of Reorganization and Disclosure Statement and Instruction Sheet intended for use in individual chapter 11 cases are now available. These forms are located on our website under the Front Counter icon at http://www.casb.uscourts.gov/html/latest_forms.htm. While the document is not mandatory, must be adapted to the particular circumstances of each individual chapter 11 case, and may not be appropriate in all individual chapter 11 cases, we believe that it will be a substantial benefit to the Bar.

As Chief Judge, I thank my colleagues Judge Louise DeCarl Adler and Judge Christopher Latham for their leadership in this effort. I also extend the Court's thanks to the attorneys who served on the committee involved in drafting these documents, Acting United States Trustee Tiffany Carroll and attorneys Christine Baur, Todd Curry, Edward Fetzer, Andrew Griffin, and Michael O'Halloran. Without the diligence of these Committee members, this effort would have languished.

Finally, I advise that the hard work of Judge Adler, Judge Latham, and many of these Committee members has not ended. Most Committee members, as well as United States Trustee Staff Attorney Haeji Hong, will now commence phase two of the project. The intention is to prepare some form motions and other documents for use in the individual chapter 11 cases.
